**Solutions worth fighting for

The plan was to seal the deal on reconciliation — and its **game-changing investment in every aspect of children’s lives** — then take up roads, bridges and broadband.

That best-laid plan has hit turbulence. As best-laid plans often do. Supporters and advocates are now fighting to ensure that the package continues to provide long-term solutions to long-term problems, such as child poverty and hunger, while building the foundation for all children to thrive and prosper during and after our COVID-19 recovery.

**Among the solutions worth fighting for:**

- **A road out of child poverty:** Full refundability of the Child Tax Credit for [29 million of the country’s lowest income families](#). Expanded CTC benefits. Monthly delivery of benefits. Expansion and permanence for [other child-friendly tax credits](#). [More than 250 organizations](#) have joined First Focus Campaign for Children in this fight.
- **Equality for children’s health care:** The **Children’s Health Insurance Program (CHIP)** must be given [the same status — permanence — as Medicaid, Medicare, and every other federally funded health care program](#) — including the one members of Congress enjoy. [More than 500 organizations](#) have joined First Focus Campaign for Children in this fight.
- **Protection of mothers and babies:** Required 12-month continuous coverage for children enrolled in Medicaid and CHIP. Required increase of postpartum care for moms to one year. First Focus Campaign for Children recently joined [more than 200 organizations](#) in calling for these solutions.
- **Honoring the right of children and parents to participate in society and the economy:** The proposed \$450 billion investment in early learning, including investments in both child care and pre-K, will benefit children, families, early learning employees, and employers across the country. [Child care is the lynchpin of the U.S. economy](#).
- **An end child hunger:** Reconciliation provisions include \$35 billion to expand the reach of free school meals to nearly 9 million children; create a permanent, nationwide program to extend Summer Electronic Benefit Transfer to more eligible low-income children; permit Medicaid direct

certification to better link eligible children to free and reduced-price school meals; and increase access to healthier foods at school.

- **556,000** manufacturing jobs
- **312,000** construction jobs

By a wide 71-18% margin, voters overwhelmingly support the improvement to the Child Tax Credit included in the Building Back Better legislation passed by the House.
