### BACKGROUND AND KEY MESSAGES:

In a year marked by partisanship, several members of Congress stood out as Champions and Defenders of Children, according to the 2018 Scorecard compiled by First Focus Campaign for Children, a national bipartisan children's advocacy group.

"Even though child advocates had to fend off a whole range of legislative and regulatory attacks on children, we have identified 120 members of Congress who chose to make children a priority. We commend their leadership and hope they will inspire their colleagues to do the same," said Bruce Lesley, President of the First Focus Campaign for Children.

The 2018 Scorecard includes key votes on health-related bills and amendments to tax legislation, including two House votes on the Children's Health Insurance Program (CHIP), two Senate votes on child tax credit amendments, and four votes between the two chambers on the Affordable Care Act.
